- Won't generate and revenue until we are in the new financial model. How does SoEC have faculty resources to service all these new courses?
- Who will be creating all of these new courses – GAs or FT faculty?
- Are these questions that the CAHS Academic Affairs committee typically addresses or are these addressed in the individual schools?
